Governed by a Board of Directors made up of independent business professionals, the Mayor of Burlington and the City Manager, we lead, influence and facilitate Burlington's growth into a vibrant and economically thriving mid-size urban city. Burlington Economic Development has a varied mandate that ranges from activating new employment lands in the City of Burlington through the Burlington Lands Partnership (BLP), to developing a comprehensive brand to promote Burlington to future businesses, visitors and residents. Through our business support and growth services we work on everything from immigration support and R&D access to supporting the scale up of technology companies through Burlington's innovation centre, TechPlace.

As a member of <u>Team Burlington</u>, composed of Burlington Economic Development, Burlington Chamber of Commerce, Tourism Burlington, Burlington Downtown Business Association (BDBA), and Aldershot Village BIA, we are committed to supporting our businesses through economic recovery including the long term economic impacts of COVID-19 to our hospitality and main street businesses.

We are looking for passionate business advocates to provide strategic oversight to Burlington Economic Development in developing and delivering our new 2023 Strategic Plan and the City of Burlington Vision 2040. Applicants should have a commitment to continuous learning and applying good governance principles in their role as a board member. Preference will be provided to candidates who have an ICD Designation and/or are interested in becoming accredited directors in the future.

Burlington Economic Development is committed to partnering with our community and ensuring we have a diversity of voices around the board table. We have adopted the 50-30 Challenge reaffirming our goal that our Board and senior management achieves gender parity (50%) and a significant representation of underrepresented groups (30%) by 2023.

This volunteer commitment is not compensated and includes attendance at Board and / or Committee meetings, as well as Board Development and other activities. Board members are appointed for a 3 year term which is renewable to a maximum of 9 years of service on the board.
